

# BRACEBRIDGE RECREATION LEISURE ACCESS PROGRAM APPLICATION JANUARY 1, 2019 – DECEMBER 31, 2019

#### Intent

The Town of Bracebridge Recreation Department is committed to enhancing the quality of life for the community by ensuring age friendly, accessible and inclusive recreation and leisure opportunities.

The Leisure Access Program is a mechanism to support affordable access to recreational opportunities for residents and households living in low income.

### **Eligibility Requirements**

- Town of Bracebridge permanent residents who have lived in the Town of Bracebridge for at least 30 days and who are able to demonstrate residency.
- Households include family members and dependants residing at the same address.
- Full-time Post-Secondary students are not eligible.
- Part-time Post –Secondary students are eligible.
- A combined household income that is at, or below, the following levels:

These numbers are determined by the Statistics Canada Low Income threshold 2017

#### **Leisure Access Passes:**

Approved Leisure Access applications are valid for one year from January 1 – December 31, 2019. An approved family may choose from the list below, one pass per family member.

#### **Child / Youth** (ages 1 – 19)

Annual Child or Youth Pass, and 50% off up to 2 registered programs per year per child (Note: Leadership registered programs require the registrant to pay at time of registration for manuals, certification fees and other administrative fees)

#### Adult / Senior

- a) 52 day passes; or
- b) open annual walking pass; or
- c) 50% off annual pass (monthly payment plans available)

### **Restrictions**

- Passes are not redeemable for cash value.
- Passes must be used within the year as passes are not transferable from one year to the next.
- Card or discount transfers are not permitted outside the designated participant's household.
- Participants must register in person for any programs they wish to apply for.
- For children and youth registered programs the registrant must pay, at time of registration, their 50% contribution to the program.
- Leadership Programs require the registrants to pay, at time of registration, for manuals, certification fees and other administrative fees.
- Spring Break, Summer and Winter Camp programs are not included in the programs permitted to have discount.
- Minimum number of participants in a program must be made for registration to proceed.
